FAA approval has been obtained for technical data in this publication that affects STC or TSO design compliance.

EFFECTIVITY:

This service letter applies to Air Tractor models AT-802 & AT-802A with Wipline 10000 amphibian floats and Fire Boss converted landplanes installed per STC SA01795CH with an MVP-50T installed.

COMPLIANCE:

Mandatory compliance

BACKGROUND:

Fire Boss converted AT-802 and AT-802A aircraft per STC SA01795CH have implemented engine audible and visible annunciations. This annunciation is activated when the engine torque or ITT parameters exceed their red line values. These values are configured according to the engine variant. Newly manufactured AT-802 and 802A aircraft can be equipped with the Electronics International MVP-50T. The installation of the MVP-50T eliminates the appropriate ITT connection point for the Wipaire installed engine annunciation.

To maintain the same level of annunciation between aircraft with and without the MVP-50T, the audio capabilities of the MVP-50T must be installed and enabled to allow audio alerts for ITT and engine torque. This service letter describes the procedures for enabling this functionality on the MVP-50T and adds an additional alert for N_g . This service letter also removes the associated aural and visual alerts previously installed per STC SA01795CH (this functionality is provided by the MVP-50T alert audio and the MVP-50T Master Warning and Caution Lights.

FUNCTIONALITY:

After completion of this service letter, the MVP-50T will provide an aural "Check Engine Power" warning when N_g , ITT, and engine torque reaches a red operating limit. A momentary acknowledge switch will silence the MVP-50T audio alerts for 1 minute.



The MVP-50T Master Warning and Caution Lights provide a heads-up visual warning. The red Warning Light will blink any time the operating level of any monitored function reaches a red operating limit and the yellow Caution Light will blink any time the operating level of any monitored function reaches a yellow operating limit. Pushing any MVP-50T button, or rotating or pushing the Select knob will acknowledge the blinking. Acknowledging a yellow blinking display will cause the yellow Caution Light to go out. Acknowledging a red blinking display will cause the red Warning Light to stop blinking and go solid red. Any time another function reaches a red and/or yellow operating limit the Caution or Warning Light will once again blink.

Aural and visual warnings can be extinguished by remedying the over limit condition.

COMPLIANCE METHOD:

Configure the audio annunciations for the MVP-50T as described in the work instructions of this service letter.

Work Instructions Part A – Removing Old Annunciations

Work Instruction Notes:

Removal of the engine power aural annunciations from the Wipaire installed systems is required when utilizing the aural annunciations from the MVP-50T. Removal of the Engine Power visual indicator is optional, however it must be re-placard to "Engine Torque."

For ease of access for all work instructions, remove the top panel of the glare shield.




1. Locate the PRD-60 voice annunciation box.






2. Disconnect the 25 pin D-Sub connector from the PRD-60 voice annunciation box and locate the Check Engine Power input, pin 10.



3. Using a D-Sub pin removal tool, remove the Check Engine Power pin from the D-Sub connector. Once removed, properly cap and stow the wire. If a pin removal tool is not available, cut the wire and properly cap and stow both ends.




4. Locate the Engine Power light on the aircraft panel. **Skip to step 8 if keeping the Engine Power light installed.





5. From the backside of the light, undo the connector on the wire tail labeled "EXCESS POWER". Remove the nut on the backside of the light and remove the light assembly with the wire tail. **Optional, see step 8.



6. Properly stow the opposite wire lead. Place the nylon hole plug (Item 6) in place of the light assembly. Remove the ENGINE POWER placard and replace it with the new placards (Item 7, Item 8). **Optional, see step 8.




- 7. For AT802 two seaters, repeat steps 4-6 with the backseat panel. **Optional, see step 8.
- 8. **If keeping the Engine Power light installed, remove the ENGINE POWER placard and replace it with the ENGINE TORQUE placard (Item 13).



Work Instructions Part B – Wiring and Installation

Work Instruction Notes:

Reference the following wire schematic for the following instructions.




1. Locate and remove the MVP-50T 25 pin D-sub connector. For ease of access, it may be beneficial to remove the MVP-50T display from the panel by removing the four Philips head screws that secure the display to the panel.





- 2. Unless already installed, wire the Voice Warning Out + (pin 23) into the MVP-50T D-sub connector using a male D-sub pins (Item 3) and shielded wire (Item 1, cut to length). Wire the Voice Warning Out (pin 24) to the wire shield. (See wiring schematic)
- 3. Using the provided Molex crimp (Item 4), wire the Voice Warning Out + wire from the MVP-50T into the open pin 2 position on the P34 connector. Both the PRD60 and Wipaire LGAS will have audio outputs going to the same connector. Crimp the wire shield from the PRD60 and MVP-50T together and insert into position 1 on P34. (See wiring schematic)
- 4. Using 22AWG wire, (Item 2, cut to length) solder the audio acknowledge pins 21 and 22 to pins 1 and 2 on the provided momentary switch (Item 9). Use the heat shrink (Item 5, cut to length) to secure the wires to the switch.




5. Near the Master Caution or Master Warn light, locate a space to install the supplied momentary switch and placards. Ensure ample space to install both switch and placards in proper orientation. Drill a 1/4-inch hole and install the switch with the provided hardware.





6. Install the "VOICE ALARM" and "ACK" placards (Item 10, Item 11) as shown in the image below.





Work Instructions Part C – MVP-50T Audio Configuration

- 1. Obtain a USB flash drive and upload audio file 1012709 (Item 12) to the flash drive. Follow the 1012709 instructions if required to format the USB flash drive.
- 2. Insert the USB flash drive (Item 12) in the USB port on the front of the MVP-50T. Power on the MVP-50T and navigate to the settings menu by pressing the "Menu" button.



3. Scroll down and select "System Configurations Screens." Then select the "USB and Data Recording" menu. If prompted to enter a password, enter either 00100, 00200, or the aircraft serial number. Press "EXIT" when password is entered.





4. From the USB Flight Data File Manager screen, scroll down to the "Read All Voice Files" option and select "Yes". DO NOT power off the MVP-50T or remove the USB flash drive until the process is complete.



- 5. To test the audio file, exit to the main settings page again and select "Voice and Display Controls".
- 6. On the "Voice and Display Controls" screen, scroll down to select voice file to test. The name of the Wipaire voice file will be 1012709. Once selected, select "Yes". Voice file should play and be clear and audible.
- 7. To configure the audio file to play during torque and ITT exceedance, navigate to the main settings page and select the "Systems Configuration Screens Menu." If prompted to enter a password, enter either 00100, 00200, or the aircraft serial number. Press "EXIT" when password is entered.





- 8. From the System Configuration Screens Menu, scroll down and select the "Redlines, Limits and Color Setup".
- 9. For ITT (may be shown as SP-Y), N_g (may be shown as M1), and Torque functions (may be shown as TORQ-FTLB), select the Wipaire "1012709" as the Voice Warning file. **DO NOT** change any other parameters on these screens. The MVP-50T will prompt you to enter the second level passcode received from Electronics International at the beginning of these work instructions.

10. For ITT and Torque functions ONLY, select the "Red & Yellow Warning Logic" options and select "Warn on Red Only." **DO NOT** change any other parameters on these screens. The audio annunciations and Master Warning Light will activate only in the red range. The Master Caution Light will not activate; however, the MVP will still provide a yellow indication on screen.



11. When complete, exit all settings screens and power off the MVP-50T.

Functional Test *Optional

If the correct test equipment is available, simulate an over-torque condition and an ITT exceedance condition. Verify that the audio files play while either parameter is at or above the set redline limit. Also verify that the "acknowledge" switch is functional and silences ALL audio alerts for 1 minute.

Upon completion of inspection, enter information in Aircraft Logbook for completion of Wipaire Service Letter 266.
